## EU Live Issues

### Environmental Impact Assessment

#### Background

In October 2012, the European Commission (EC) adopted a proposal for a review of the Directive on Environmental Impact Assessments (EIA), which was adopted in 1985 and codified in 2011. The review aims at taking into account the political and technical changes of the last 25 years and to simplify the EIA process.

#### Start of trialogue

The first reading of the European Parliament provided the Rapporteur Andrea Zaroni MEP (ALDE, Italy) with a mandate for the negotiations between the European Commission, the European Parliament and the Council of the EU (trialogue). All three EU Institutions expressed their preference to agree on a compromise text before the European elections in 2014.

Together with the NEEIP, UEPG has developed an [updated position](#) with a focus on the most critical unsolved issues:

- *Disproportionate extension of the scope of the EIA* (exploration of mineral resources and all “open-air” mining activities in Annex I);
- Inclusion of “visual impact” and of subsoil;
- Definition of biodiversity with reference to the Natura 2000 Directives;
- Ex-post monitoring and mitigation measures;
- Baseline scenario.

UEPG and the NEEIP have been circulating this position and been in contact with the EU Institutions to explain our concerns.

#### Next steps

The EU institutions expect the final trialogue meeting on 11 December.

### Accident Prevention



On 27 November, High Level Panellists and participants from EU Institutions, Standardisation bodies, Trade Associations, Insurance Organisation and Company representatives of the Non-Energy Extractive Industry from across Europe discussed tools to prevent accidents.

The event was hosted by Christa Schweng, Member of the European Economic and Social Committee and Chair of the Governing Board of the European Agency for Safety and Health at Work who underlined the necessity to work together for risk prevention.

Armindo Silva, Director for 'Employment and Social Legislation, Social Dialogue' in the Directorate General for Employment, Social Affairs and

Inclusion (DG EMPL) of the European Commission, presented the latest feedback of the EU H&S Strategy consultation and EU H&S legislative framework relative to the Extractive Industry. Mr. Silva recommended that end users engaged with manufacturers and provided to them data based on feedback and machines' compliances, to work together on the Design Stage, recognised that risk assessment was an



essential step in prevention of OSH, as working together with and between social partners and supporting SMEs in OSH.



After the presentation of Martin Isles (MPA and UEPG Committee H&S Chair), a common

consensus was towards the importance of use of good practices and initiatives as Safer by Design to trigger standardisation to state of play.

Safety was seen as a top priority for the whole supply chain. The European Minerals Foundation Forum was a start of the dialogue between manufacturers, users, standardisation and authorities on regular basis to working together toward standardization, education and implementation in order to reach common Health and Safety thinking, behaviour and culture in the whole supply chain in Europe for zero accident targets.

### **Risk Prevention**

On 11 and 12 November, the European Agency for Safety and Health at Work (EU-OSHA) Summit on Working

together on Risk Prevention took place in Bilbao, Spain. César Luaces Frades (FdA) participated to the event and represented UEPG to take part in the debate on 'Good practices in management leadership and worker participation', 'Benchmarking in occupational health and safety' and 'Successful networking and campaigning in occupational Health and Safety'.

The Summit was the last EU-OSHA event on the campaign on risk prevention. The next Healthy Workplaces Campaign 2014-2015 would be on practical solutions for psychosocial risks and priority topics in the area of Working Environment.

### **Construction Products Safety**

The European Commission has proposed a new package of legislative and non-legislative measures to improve consumer product safety and to strengthen market surveillance of products in the EU. The package, adopted by the European Commission on 13 February 2013, was debated in the European Parliament. It was expected that the new legislation would come into effect in 2015. The Regulation on consumer product safety (COM(2013) 78) did not impact on the Construction Products Regulation (CPR) but it covers construction products and established requirements. Amendments by the European Parliament's Internal Market and Consumer Protection (IMCO) Committee not only created additional burden for manufacturers but were also redundant with CPR current requirements.

### **Avoiding additional burden**

In close cooperation with the Association Construction Products Europe (CPE), UEPG and other CPE-Members achieved that the European Parliament accepted an amendment to

exclude construction products from the above mentioned Consumer Product Safety Regulation. This means that construction products would not be subject to any further requirement about the country of origin or the new marking "EU safety tested"; thus a success in avoiding new burden.

### **Minventory Workshop**

Led by the British Geological Surveys, Minventory aims to gather 'Statistical information on EU raw material deposits'. The project was commissioned by DG Enterprise & Industry in January 2013 and will run for 2 years, closely linked with the objectives of the EU Raw Materials Strategy.

The main focus is on the analysis of available geological data to establish a pan-European database on resources and reserves of non-energy, non-agricultural raw materials, to publish a Road Map and a Year Book.

### **Sectoral Social Dialogue**

The last 2013 meeting of the Sectoral Social Dialogue Committee Extractive Industry (SSDCEI) took place on 29 November. Miette Dechelle from the UEPG General Secretariat briefed SSDCEI-Members on the European Minerals Foundation Forum addressing accident prevention, Safer by Design and the achievements of the Explosives for civil uses Task Force. The SSDCEI strongly supported these activities which will be mirrored in the Social Dialogue 2014 Programme.

The new Chair of the SSDCEI is Philip E. Garner (EURACOAL President and Director General of CoalPro, UK); Vice-Chair is Jean-Pierre Damm (industriAll, Employees' Representative).

The next meeting will take place in February 2014.

This year, the independent Jury had to make a selection out of a record number of 52 excellent entries from 14 countries, including Austria, Bulgaria, Cyprus, Finland, France, Germany, Greece, Poland, Romania, Spain, Sweden, Switzerland, The Netherlands and UK.



The 2013 Awards Ceremony was hosted by Sirpa Hertell (EPP, Finland), Member of the Committee of the Regions and working on Natural resources and Environment. It took place in the prestigious Brussels Centre of Fine Arts (Bozar).



The Master of Ceremonies, UEPG Past-President Jim O'Brien, presented

the excellent entries to an audience of almost 130 participants from all over Europe, among them, honourable Members of the European Parliament and representatives from the European Commission. Special guest was the Catalan Minister of Agriculture and Natural Environment, Josep Maria Pelegrí.

At the Ceremony, UEPG President, Arnaud Colson and Secretary General, Dirk Fincke handed over the 32 certificates to company representatives. The host of the event, Sirpa Hertell, and Jury Members presented the 19 Awards. All entries are published in a brochure and will be part of a touring exhibition in EU Institutions further raising public awareness at highest EU level to what the European Aggregates Industry can achieve on sustainable development. UEPG Vice-President, Elisabeth Gammelsæter closed the 2013 UEPG Sustainable Development Awards Ceremony with a poetic touch.

### ForumMIRO 2013

More than 450 participants and 60 exhibitors attended the ForumMIRO organised by the German Aggregates Federation (MIRO). Former European Commission Vice-President Günter Verheugen defended the European idea but criticised the bad industrial policy of the Commission increasing ever more the administrative and financial requirements for companies.



During several break-out sessions, participants could choose between technical and political themes. MIRO also invited speakers from the German Environment Ministry explaining a new regulation on environmental compensation.
